PROCUREMENT OF MEDICAL SUPPLIES/EQUIPMENTS FOR USE IN OPD AND LABORATORY AT RHU - AYUNGON, NEGROS ORIENTAL

1. The **Municipality of Ayungon**, through the **General Fund 2021** intends to apply the sum of **Five Hundred Twenty One Thousand and Three Pesos (521,003.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Procurement of Medical Supplies/Equipments for Use in OPD and Laboratory at RHU - Ayungon, Neg. Or.** Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The **Municipality of Ayungon** now invites bids for **Supply and Delivery of Medical Supplies/Equipments**. Delivery of the Goods is required within **Thirty(30) days after issuance of Purchase Order (PO)**. Bidders should have completed, within **30 days** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from the **Municipality of Ayungon**, and inspect the Bidding Documents at the address given below during **8:00 AM to 5:00 PM**.

5. A complete set of Bidding Documents may be acquired by interested Bidders on **June 29- July 5, 2021 in the amount of One Thousand Pesos (Php 1,000.00) only**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The **Municipality of Ayungon** will **NOT** hold a Pre-Bid Conference on this project.

7. Bids must be duly received by the BAC Secretariat at the address below on or before **July 5, 2021, at 2:00 PM**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.

Bid opening shall be on **July 5, 2021, at 2:00**, at SB Session Hall, Municipality of Ayungon. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

Bid opening shall be on **July 19, 2021, at 2:00**, at SB Session Hall, Municipality of Ayungon. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

All interested bidders/suppliers who will submit their bid documents such documents should be properly tabbed. Eligibility documents should be three (3) copies in each separate folders.
