### CLUSTER OF CONSTRUCTION PROJECTS CLUSTER 3 AT AYUNGON NEGROS ORIENTAL

1. Road Concreting: Portion of Proper Poblacion – Atabay Proper Awa-an Road, Ayungon Negros Oriental – **P1,000,000.00**
2. Road Concreting: Portion of Crossing Candana-ay Road Sitio Natagakan, Ayungon Negros Oriental – **P1,000,000.00**

### BID IDENTIFICATION NUMBER **2022-02-06**

1. The **Municipality of Ayungon**, through the **20% - LDF 2021** intends to apply the sum of **Two Million Pesos. (2,000,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Cluster of Construction Projects Cluster 3 at Ayungon Negros Oriental**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Municipality of Ayungon**, now invites bids for **Cluster of Construction Projects Cluster 3 at Ayungon Negros Oriental**. Completion of the Works is required at **90 calendar days** Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”  
Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from **Municipality of Ayungon**, and inspect the Bidding Documents at the address given below from **8:00 AM to 5:00 PM**.
5. A complete set of Bidding Documents may be acquired by interested bidders on **February 11-24, 2022, in the amount of Five Thousand Pesos (Php 5,000.00) only**.  
It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
6. The **Municipality of Ayungon**, will hold a Pre-Bid Conference on **February 11, 2022 at SB Session Hall, 2:00 PM Municipality of Ayungon** which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **February 24, 2022, at 2:00 PM**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.

Bid opening shall be on **February 24, 2022, at 2:00 PM.** at SB Session Hall, Municipality of Ayungon. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. **All interested bidders/suppliers who will submit their bid documents such documents should be properly tabbed. Eligibility documents should be three (3) copies in each separate folders.**
  
9. The **Municipality of Ayungon**, reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
