- 7. Bids must be duly received by the BAC Secretariat at the address below on or before October

21, 2021, at 2:00 PM. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18...

Bid opening shall be on October 21, 2021, at 2:00 PM. at SB Session Hall, Municipality of Ayungon. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

- All interested bidders/suppliers who will submit their bid documents such documents should be properly tabbed. Eligibility documents should be three (3) copies in each separate folders.

The Municipality of Ayungon reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
