## INVITATION TO BID

### PROCUREMENT OF ONE (1) UNIT BRAND NEW 4x4 PICK-UP TRUCK MANUAL TRANSMISSION AT AYUNGON, NEGROS ORIENTAL

#### BID IDENTIFICATION NUMBER 2021-05-28

1. The Municipality of Ayungon, through the General Funds/Supplemental Budget No. 1-2021 intends to apply the sum of **Two Million Pesos (2,000,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for Procurement of One (1) Unit Brand New 4x4 Pick-Up Truck Manual Transmission at Ayungon, Neg. Or. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Municipality of Ayungon now invites bids for Supply and Delivery of Pick-Up Truck. Delivery of the Goods is required within Sixty (60) days after issuance of Purchase Order (PO). Bidders should have completed, within **30 days** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from the Municipality of Ayungon, and inspect the Bidding Documents at the address given below during **8:00 AM to 5:00 PM**.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **June 9 – 21, 2021 in the amount of Five Thousand Pesos (Php 5,000.00) only**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The Municipality of Ayungon will hold a Pre-Bid Conference on **June 8, 2021, SB Session Hall, 2:00 PM**
7. Bids must be duly received by the BAC Secretariat at the address below on or before **June 21, 2021, at 2:00 PM**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
